Our establishment agrees to exercise due and reasonable care and to keep the premises sanitary and properly enclosed. Your pet will be fed, watered and housed in safe, clean quarters. It is our goal at Schmidt's Country Kennel to provide top quality pet boarding.

The services we provide are done so without liability for loss or damage from disease, death, running away, theft, or fire and from injury or damage done by your pet to people, other animals, or property, or other unavoidable causes. The undersigned releases Schmidt's Country Kennel, its owners, and employees, from all risk and damage which may occur during your pets stay. Therefore, the undersigned pet owner agrees to be solely responsible and liable for any and all acts of behavior by their pet. This release applies to pets for any purpose, including but not limited to boarding, grooming, daycare and training.

Should your pet become ill or need medical attention, Schmidt's Country Kennel has the right to administer aid and to render care by your veterinarian, if available, or by our chosen veterinarian. The pet owner gives Schmidt's Country Kennel the authority to transport their pet to said veterinarian for treatment and the pet owner agrees that they are responsible for payment of medical care provided regardless of cost and whether they have been reached for specific instruction or not.

The pet owner has made sure their pet is up to date on vaccines, provided proof from their vet and that their pet is free from illness and disease. The pet owner has provided proof that their pet has received flea/tick treatment in the last 30 days and if not, one will be applied at the pet owners expense.

The pet owner acknowledges and accepts that if they have chosen for their dog to take part in group play with other dogs, there are risks involved. Any time dogs play together there is the possibility of injury from rough play or combative behavior. The pet owner understands that injuries such as scratches, bites, lacerations or other trauma may occur as well as transmission of disease.

No pet shall be released until all charges are paid in full. In the event of an unpaid bill, the pet owner agrees to pay legal fees and costs incurred by the kennel in the collection of outstanding bills. The pet owner agrees to notify the kennel in advance if there is any change in the pets pick up date. Any pet left uncalled upon for seven days from the scheduled pick up date, as noted herein, shall become the property of Schmidt's Country Kennel. Fees incurred for the care and/or placement of the pet in a new home are the responsibility of the undersigned pet owner and will be turned over to collection.

The provisions of this agreement apply to any further time the undersigned pet owner uses any services for this and any other pet at Schmidt's Country kennel. This agreement will be signed only once.
